



LOTUS BAKERIES NV CAPITAL INCREASE THROUGH THE EXERCISE OF WARRANTS

Today, Lotus Bakeries has increased its issued capital following the exercise of 150 warrants by Lotus employees. In this way the number of Lotus Bakeries shares has risen from 814,283 to 814,433. The 150 newly issued shares are scheduled to be listed on Euronext Brussels on 9 October 2017.
